As a result, concept of an animal/human acquiring wings after consumption of Red Bull Energy Drink has become exclusively associated with it and Dr Reddy's registered trademark with tagline "Your Wings to Life" which has not been in use yet has been attempting to create confusion in the minds of consumers. IPAB while clarifying the law of the land in this matter upheld that both trademarks have no deceptive similarity thereby dismissing the petition.

This has resulted into "cyber syndemic" – a digital contagion combined with a health epidemic. Sellers of these herbal remedies portray

Delhi High Court has directed AAP Government to begin online registration of legal documents including wills, to reduce stress for general populace and limit human contact during pandemic times. Though e-registration of documents has been implemented in several states, this direction has come in the light of prevailing provisions in the High Court with respect to e-filing of cases where a litigant can file a petition and even pay court fees from the comfort of his/her office or home. In the light of prevailing risk as a result of COVID, many sub registrars have been refusing to register wills and other documents of senior citizens, persons with comorbidities and pregnant women. Online registrations are the need of the hour and about

time that positive contributions of technology are acknowledged and put to value creating use for benefit of larger good.

The exemptions for startups have now been extended for another 10 years from the date of its incorporation as per the deposit rules amended by Corporate Affairs Ministry. As per

this new amendment, an amount of Rs 25 lakhs or above received by Start up through convertible note in a single tranche or repayable within a period of not exceeding 10 years from the date of issue will not be considered as deposits. Prior to the amendment, the limits of total deposit from members did not apply to a start up for 5 years from date of its incorporation. Now any private start up firm would be able to accept deposit from its members without any limit till 10 yrs from its incorporation.

A parliamentary panel has recently proposed tax incentives for startups including removal of long-term capital gains tax on investments in such companies. The basic premise behind this proposal being propelling of investments, jobs and demand creation in economy on account of strong and robust start up ecosystem. The initial proposal is that the abolition of this tax should be for at-least next two years to encourage investments. Recommendation has also been made for application of Securities Transaction Tax so that revenue neutrality is maintained.

But European Court of Justice had ruled that Messi is too well known so there is no scope of any kind of confusion. The Appeal was thereafter dismissed. Messi has been crowned as World Football Player of the year six times and is also the world's highest paid soccer player.

Star India Private Limited has been granted relief by Delhi High Court in interim applications filed by it against Jacstremas.com & Ors. This particular suit was filed for website blocking on account of illegal and unlawful activities pertaining to defendant websites. The bone of contention in the matter is communication to the public of Dream 11 India Premiere League, 2020 by defendants for which plaintiffs have claimed exclusive television, mobile, internet and mobile activation rights worldwide. Defendant websites are alleged to be having servers outside India which become alive and begin to stream only during the course of the match. An ex-parte ad-interim injunction has been granted in this matter restraining defendants from communicating, streaming, hosting or making available for viewing or downloading in any manner without authorization, of Dream 11 IPL, 2020 league.
