

**ECONOMICAL PLANET TRAVEL VIA RECYCLABLE ROCKETS**

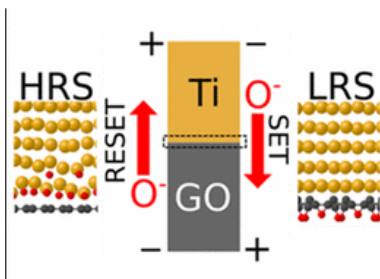

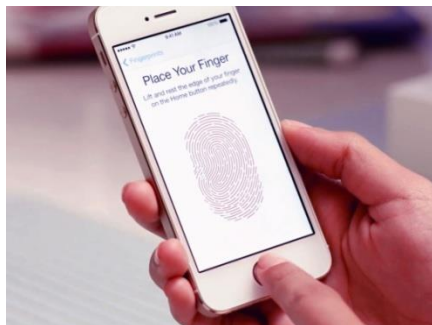


**Madras high court**

**DABUR & AYURVEDA**

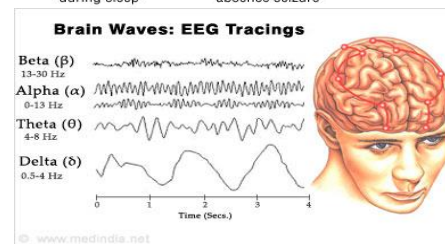
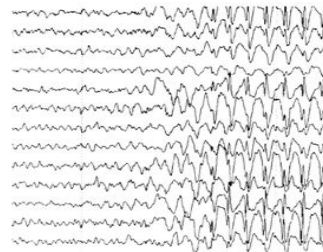

**BLINDNESS REDEFINED BY WHO**

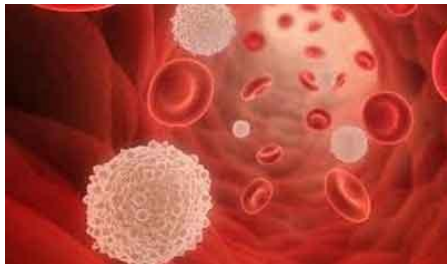

Thus, the court stated that filing of false allegations and cases is cruelty and husband is entitled to divorce on that ground. The bench opined that the definition of cruelty can never be defined with exactitude and would be dependent on facts of each case. In the present case, the frivolous allegations were apparent which tarnished the image of the husband.

**PLAGIARISM ALLEGED ON CHETAN BHAGAT**
