Termed as a phenomena depicting sexual discrimination or harassment, Campaigners made a hue and cry about wearing high heels being seen as near obligatory when job hunting or working at many Japanese companies.

ZEN COINED WORD FOR MOBILES Ref: www.livelaw.in, Thursday, 06.06.2019



In a suit filed by Telecare Network Private Limited, Delhi High Court has passed an interim order restraining mobile and laptop manufacturing company Asus Technology from using the mark "ZEN", "ZENFONE" and other similar terms while selling mobile phones and other products. While clarifying the law as laid under Section 17 (2) of the act, the High Court stated that the whole rationale behind grant of recognition and protection of trademarks and trade names is to ensure that people don't get confused about the source of goods and services. The court held that since ZEN is a generic word qua a school of Buddhism, yet it is not a generic mark with regard to mobile phones and tablets as the said word has no correlation with or connection with mobile phones and tablets. The adoption by Asus was malafide and thus not covered under this defence.

GREEN FUEL BIO WASTE Ref: The Times of India, Monday, 10.06.2019



A Biotech student has novated method of converting organic waste to bioethanol, a clean fuel which reduces greenhouse gas emissions. This process involves working on microbial co-culture, considered as a producer of bioethanol. Survey and reports suggest that for ethanol production in India, farmers should be encouraged to cultivate energy crops such as sugarcane, beetroot, and corn.

Delhi High court has recently directed the Trademarks Registry to consider all applications for renewal of trademarks that have no record of mandatory notice under Section 25 (3) of the Trademarks Act, 1999. While outlining the mandatory nature of the law, the high Court has directed that strict adherence be made by relevant parties towards these important provisions.

JUMPING GENES AND GENE EDITING Ref: The Times of India, Friday, 14.06.2019



Scientists have recently discovered technique using "jumping genes" also known as transposons that can effectively slide into the DNA without cuts offer a seamless, safer and a novel alternative to edit genes. A key tool for editing is the CRISPR-Cas9 process, which uses CRIPRs—a part of the immune defense system in bacteria – to locate a target in the DNA, and the protein Cas9 to "snip" the DNA strand. The DNA then repairs itself, sometimes guided by a template that is inserted during the editing process. But the process is not always effective.


HUAWEI TRADEMARK MOBILE OS Ref: The Economic Times, Friday, 14.06.2019



China's Huawei, has applied for trademark its"hongmeng" operating system (OS) in at least nine countries and Europe, as a sign it may be deploying a back-up plan in key markets as US sanctions threaten its business model. PASSING OFF OF REGISTERED DESIGN PERMITED

Recently, the Delhi High Court while questioning the legality of order passed by single bench has sought to clarify the defining and overlapping characteristics of design and trademark law. The lower court had laid down that a registered design cannot constitute a trade mark until there are any extra features other than those registered as design and the most defining characteristic has to be that those extra features should have acquired goodwill. This order was challenged in appeal and that is when the division bench stepped in to clarify the law. This appeal was filed by multinational footwear manufacturer Crocs. Their case was that the distinct design of the footwear can be used as a 'trademark' on the ground that under Trademarks Act 1999. shape can be a trademark and hence action of passing off based on the design was maintainable.

TELECOM INFRA AGAINST COPYCAT WEBSITES Ref: The Times of India, Monday, 17.06.2019



Fake websites trying to hack prospective customers and clientele with similar logos and phone numbers operating in their name has triggered action by ATC INDIA. The gang has been taking money from people by promising to install telecom towers on their property for a good rental income. ATC India got the FIR registered after discovering the

large-scale fraud under IPC and Copyright Act. A preliminary investigation revealed these websites and when they were accessed, these fake websites even displayed toll free numbers along with a series of mobile phones numbers to take inquiries.

BP DRUG REDUCES ALZHEIMER Ref: The Times of India, Wednesday, 19.06.2019



A study has recently revealed that a high blood pressure drugnilvadipinehas the potential to slow down Alzheimer's disease by improving the flow of blood to parts of the brain linked to memory.

The findings indicate that the known decrease in cerebral blood flow in patients with Alzheimer's can be reversed in some regions. Nilvadipine is a calcium channel blocker that is used to treat high blood pressure.

An interim order of injunction has been passed by Bengaluru court against Google India, directing it to refrain from diverting the traffic of the official site of crowd funding platform "Milaap". In a complaint filed by "Milaap", it was alleged that traffic to its site was being diverted to www.impactguru.com. another site Apparently on searching the mark "Milaap" on Google, the first entry that appears is that of website "Impact Guru", which is also a crowd funding platform. This intentional diversion of traffic by impact guru has been subject matter of litigation between the parties. The court eventually held it to be a prima facie case made by milaap and ordered restraint.
