Food Safety and Standards Authority of India

Hon'ble Apex Court refused to interfere in the order of Delhi High Court which upheld that the Plant varieties and seeds cannot be patented under Indian Patent Law. The Monsanto patent was decreed to be unenforceable in India. However, the court has kept the matter pending for July 18, 2018 and has stated that the company shall continue its obligations under sub-license agreements. The suit can proceed for damages and other reliefs only as the Patent has been declared to be invalid.

REGULATING MEDICAL DEVICES Ref: The Economic Times, Friday, 25.05.2018



Critical medical devices which are implanted inside human body are not regulated by the authorities and law till now. Though, these products have a major impact on the human body and despite cases of substandard medical devices, the same has not come within the purview of the Central Drug Standard Control Organisation CDSCO completely. In India, most implantable devices are unregulated, including pacemakers, implantable cardioverter defibrillators used to perform cardioversion, defibrillation, and pacing of the heart, neurostimulator systems, implantable gastric stimulators, glucose monitors, and infusion pumps for insulin. The companies would then have to seek permission from the Drug Controller General of India and take licenses for selling the products in India. This regularization is the need of the hour with the high increase in use of these medical devices in India.

Amending the law to enhance prison for offenders' who abuse elders from three to six months, has recently been discussed by the plethora legal stakeholders. The petition stated that the commercial shows a similar action, plot and campaign maligning the repute of Voltas with phrases "Ganda Hai". The company has also claimed that as per the guidelines of Advertising Standards Council of India, the comparative advertisements have to be supported by data which is missing in Haier's case. The other players being Blue Star and Godrej also aver about the damaging advert of Haier. Whether the dispute is pertaining to the advert or the share of each player in the market is something which will unveil shortly.

EXCISE LICENSE REGULATES MUSIC PERMISSIONS

In an unprecedented move, the Excise Department of the Delhi Government has warned pubs and restaurants to not play recorded music but only live or instrumental music.
