The Delhi High Court on 13th December 2017, refused to grant an permanent injunction to the owners of the website bookmyshow.com against a company from using the mark 'bookmysports.com' or using the prefix 'bookmy' in their domain name stating that the phrase "BOOKMY" is not an arbitrary coupling of two English words. It is instead an apt description of a business that is involved in the booking of a particular thing for its consumers, whether it is a concert, a movie, or a sports facility. Thus, it was held that the mark 'bookmyshow' has not acquired any distinctiveness and relief was denied.

The Court found that the mark A+ was a descriptive mark and as a result is incapable of protection under the Trademark Act 1999. without

being used in conjunction with another mark. In order to protect a descriptive mark, one has to show that it has acquired distinctiveness in the market. The Court directed the parties to maintain the status quo, and remanded the case back for rectification proceedings before the IPAB.

OSHO

The European Union in Luxembourg upheld the ownership of the OSHO trademark by Osho International Foundation (OIF), an organization under Swiss law. Known initially as the itinerant monk Acharya Shree Rajneesh who delivered talks in poetic Hindi during the 1960s in northern and western India, he controversy with sparked а his provocative three-part public talk. Within India, the OIF does not exercise strict control over the OSHO trademark and copyrights that it owns on the guru's meditations, talks and audio-video discourses. Outside India, especially in Europe, the OIF has been known to use its legal might to prevent anyone from using OSHO without paying license fees and royalty and with this ruling the mark has been upheld.
