Keeping in view the significance and scope of redefining the interest of consumers in the present era of globalisation and free market economy the RGNUL organised a National Seminar on 'Consumer Activism, Competition and Consumer Protection' under the aegis and Centre for Consumer Protection Law and Advocacy (CCPLA) in collaboration with Centre for Consumer Studies, Indian Institute of Public Administration, New Delhi. The event was supported by the Ministry of Consumer Affairs, Government of India. Vital issues were deliberated like: Consumer Activism, Consumerism and Effect of Globalisation, Competition law and Consumerism; Intellectual Property Rights, Technology and Consumer Protection; Challenges before Redressal Mechanism, and Regulatory Issues in Consumer Protection. Selected papers were published in the book titled *Consumer Activism, Competition and Consumer Protection*, which was released on the Inauguration of the Seminar.

HUMAN RIGHTS ADVOCACY: GLOBAL APPROACHES, LOCAL EXPERIENCES, A RGNUL PUBLICATION - 2011

RGNUL published its first book entitled as *Human Rights Advocacy: Global Approaches, Local Experiences in 2011*. The edited book was contributed by authors from various countries including India. The book was released by Hon'ble Mr. Justice S.S. Nijjar, Judge, Supreme Court of India and Visitor RGNUL on 26 March 2011.

RGNUL ONLINE LEGAL NEWSWEEKLY

In order to undertake advanced study and interdisciplinary research on major national and international legal issues, with the doctrine of Human

Rights and Human Dignity at its substantive core, RGNUL launched its first online weekly publication "**Human Dignity: Legal News and Research**". Professor (Dr.) S.R.S. Bedi, Professor of Law, RGNUL is the Chief Editor of this publication. The publication aims to provide a platform for discussion on the issues related to Human Rights and Human Dignity and also find solutions related to the problems that affect the human beings in the present times.

ACTIVITIES OF THE RGNUL LEGAL AID CLINIC

Research Project

The postgraduate paralegals have actively worked for the RGNUL Legal Aid Clinic by preparing Research Projects, dealing with various cases, attending to the clients, drafting their applications and assisting them for solving their legal issues at the District Courts, Patiala.

Seminars and Workshops

The paralegals of the Clinic of RGNUL arranged a meeting of NGOs, CDPOs, Juvenile Welfare Committee, the District Administration and the RGNUL faculty on 4 October 2011, which focused on the legal awareness and empowerment of women, children and the marginalized section of the society. The meeting was presided over by the Registrar of RGNUL, Professor (Dr.) G.I.S. Sandhu, who stressed upon the need to spread legal awareness at the domestic level of the society. The Assistant District Attorney Mr. Tajinder Singh Bal and District Programme Officer emphasized upon the need for the protection of the women and destitute and the members of RGNUL pledged their full support to provide legal services to those who cannot afford a counsel in the courts.

The students of RGNUL participated in a One day Workshop on Free Legal Aid to Illegal Immigrants, at Judicial Academy, Chandigarh on October 2011, where they were made familiar with the plight of the illegal immigrants, the role played by law in helping the victims and also about educating people regarding illegal immigration.

Child Development Programme

RGNUL Legal Aid Clinic is actively associated with the National Child Helpline NAVJIVINI - an NGO and is also in collaboration with the Ministry of Women and Child Development in India for rescuing and rehabilitating children from the clutches of child labour. The paralegals and the faculty of RGNUL have been trying to spread awareness on child rights and also curb the menace of child labour at the district level.

Legal Awareness Booklets

The Paralegals at RGNUL with the initiative of the Punjab Legal Services Authority, Chandigarh have undertaken the project of preparing Booklets on various legal issues, to spread awareness amongst the masses. These Booklets cover the issues like MGNREGA, Sarv Shiksha Abhiyaan, Domestic Violence, Dowry Laws, Immigration Laws, RTI, Human Rights, Adoption Laws, etc.

CENTRES/UNITS ESTABLISHED AT RGNUL UNDER UGC SCHEMES

Since RGNUL is registered with UGC under Section 2(f) and is recognized under Section 12B of the UGC Act, 1956, it got grants under different UGC schemes of XI plan, to set up some Centres/Units with specific objectives. Accordingly, Centres/Units have been established as under:

RGNUL Internal Quality Assurance Cell (IQAC)

RGNUL has established an IQAC for which it has received a grant of Rs. 4.5 lac out of total sanctioned grant of Rs. 5.0 lac from the University Grants Commission, New Delhi. The objective of the IQAC is to channelise and systematize the efforts and measures of the institution towards academic and administrative excellence. It also aims at planning, guiding and monitoring different activities of the University to assure access, equity and quality in the higher education.

Day Care Centre

RGNUL inaugurated a Day Care Centre, on 7 February 2012 at the University premises for the kids of the teaching and the non teaching staff. The Centre has been established using the grant from the UGC and has number of facilities like Music, Beds, Toys,

Books, Children CDs, Refrigerator etc.. The Centre would also take care of proper nourishment, hygiene and pre-school education of the children.

Enabling Unit

In consonance with the XI Plan guidelines of the UGC, the University has established an Enabling Unit. The main objective of the unit is counseling, promoting and facilitating the differently abled persons for education, career options and gain employment. The unit is

established to create legal awareness amongst the different sectors regarding the disability issues. It aims to make efforts to foster opportunities for the differently abled, create an empowering discourse on the rights of the disabled through active research and training sessions and also to assess the educational needs of the differently abled persons enrolled in higher education institutions.

STUDENTS' EXCHANGE PROGRAMME AND MOU'S

With a view to adopt interdisciplinary approach in the professional legal education the RGNUL has taken initiative to enter into memorandum of understanding with other professional and technical educational institution at the national and international levels. The objective is to take the benefit of facilities and expertise available with different professional institutions leading to gainful partnership for mutual benefit.

To implement these programmes the RGNUL has framed/modified its regulations. These lay down the norm for availing these benefits, by the students of graduation and post-graduation courses. The duration of exchange may vary from a short term to full semester Course.

COLLABORATION FOR ONLINE COURSE ON DEMONSTRATIVE ADVOCACY

The University has signed a Memorandum of Understanding (MOU) with Fancy Barristers – a leading law firm from Canada, under the Career Exchange Programme for the students of B.A.LL.B. (Hons.) Course. Under the agreement, it is decided that from July 2012, RGNUL will offer its students an optional course on Demonstrative Advocacy – a litigation methodology devised by Dr. Hassan Fancy of Fancy Barristers. Only the students who have completed at least their first year of the graduation course can get enrolled for this course. Moreover, the Canadian Firm intends to offer one month's internship each year to four meritorious students of RGNUL with a renowned litigation firm at Canada.

In the last academic session the RGNUL students were staying in four different hostel buildings, viz. State College

of Education, Patiala, Boys and Girls Hostels and Two Boys Hostels in the hired buildings at Factory Area, Patiala and Urban Estate, Phase-I, Patiala. In July 2011 all boys and girls students have been shifted to RGNUL Sidhuwal Campus on completion of their respective Blocks and necessary facilities /amenities like electricity, water supply, generator backup, sewage system, Wi-Fi connectivity, Health Services, Security Services etc. Since academic activities are still being continued from the Mohindra Kothi Campus the conveyance for the students has been provided through two University buses and two hired buses. Each bus makes two trips both in the morning and the evening.

The hostels are duly furnished and these are also provided with AC facilities at the rates approved by the Executive Council. Separate Mess Contractors are operating at these Hostels at Sidhuwal Campus. The Vice-Chancellor addressed all the students from the new batch and their parents at the New Campus on 12 July 2011.

PROVISION OF FACULTY HOUSES

A block of 12 faculty houses got ready in August 2011. These houses have been allotted to teachers and at present 11 houses are occupied by Professor, an Associate Professor and nine Assistant Professors. In one of the houses a make shift arrangement has been made for the Health Services and the Canteen.

SETTING UP OF PLANTS NURSERY.

Plants Nursery is being developed in the campus, to cater to the day to day needs for the landscaping, plantation and works to maintain the flower beds in the campus etc.

SOLID WASTE MANAGEMENT AND VERMICULTURE

Solid Waste Management is being done in the campus by separating the degradable and non degradable materials. Degradable material will be processed under Vermiculture System, and we will get sufficient produce of vermi compost. This will be used in gardens / flower beds etc. The non degradable materials can be recycled and sold

SEWAGE TREATMENT PLANT (STP)

Sewage Treatment Plant (STP) of 200 KLD capacity has been made functional. Treated waste water being received from the Sewage Treatment Plant is being used

for irrigation purposes. There is also a provision for reuse of treated waste water for flushing if there is no irrigation requirement.

WATER HARVESTING

Recharge wells are being provided to cater the disposal of rain water into the ground. This will surely conserve/harvest water, and will safe guard the campus from flooding.
