NGT DIRECTS CPCB TO PREPARE A NOISE POLLUTION MAP

National Green Tribunal recently while adjudicating matter of Hardeep Sigh & Ors. vs SDM & Ors. case, has directed the Delhi Administration which has launched a ngms.delhi.gov.in; registration of grievances regarding noise pollution. A user can register their grievances online and action will be taken within 30 minutes. This website will display guidelines on the limits set for vehicles, diesel generator firecrackers and also norms, in general, for residential and industrial areas. As confirmed by the revenue department, the website will be used to receive and disseminate information to the public on noise pollution. A helpline number -155271 - has also been set up for people to inform the police about any violation. This is a major step for curbing the noise pollution for Delhi and indeed a relief for general public if the same is enforced in spirit.

Ministry of Corporate Affairs is considering to have a system where companies can geotag and furnish pictures of projects undertaken under their corporate social responsibility programs to the government. There will also be introduction of penal provisions to deal

with companies failing to meet their CSR obligations. Parliament has already approved amendments to the Companies adding that provisions companies criminally liable for CSR violations. As a settled law, Companies with a minimum net worth of 500 crore, turnover of 1,000 crore, or net profit of 5 crore, are required every year to spend at least 2% of their average profit for the previous three years on CSR activities. With these provisions, it is imperative that the corporates would work towards the society regeneration and preservation as a whole.

Researchers have developed an effective nano-vaccine for melanoma, the most aggressive type of skin cancer. This method has so far proven effective in preventing the development of melanoma in mouse models and in treating primary tumours and metastases that result from melanoma. The focus of the research, is on nanoparticle that serves as the basis for the new vaccine.

ARTIFICIAL TONGUE FOR WHISKY TASTERS

Scientists at Glasgow University have built miniature taster or artificial "tongue" which can distinguish subtle differences between whiskies. Whisky is poured over a chequerboard pattern of tiny pieces of gold and aluminum - which act as "tastebuds" - and researchers then measure how they absorb light while submerged. It can even tell the difference between the same brand aged in different barrels, with more than 99% accuracy. It can also distinguish between whiskies aged 12, 15 and 18 Years. It could be used not only for quality control but also to combat the booming counterfeit alcohol trade as the method found several hugely expensive bottles of whisky to be fake.

FARM STUBBLE PROFITABLE Ref: The Times of India, Friday 09.08.2019



Stubble burning continues unabated in the Indian agricultural sector every year in October-November, when millions of acres of burning fields contribute to 'Airpocalypse' that chokes the entire North Indian region. Researchers have indicated use of alternatives like of happy seeder along with straw management systems can actually give farmers up to 20% higher returns than the most common method that involves burning stubble. Happy seeder is a tractor-mounted implement, developed at Puniab Agricultural University, Ludhiana that can sow seeds in fields where stubble from the previous crop hasn't been removed. The straw acts as mulch retaining moisture in soil and providing nutrients to future crops. This technology and product if implemented will be extremely beneficial for the Agri sector.

Recently, few Startups and angel investors had come under the scanner after the companies had issued shares at prices that were said to exceed their fair with the difference market value, considered taxable as income from other sources. Central Board of Direct Taxes in the light of addressing this issue has come up with a few guidelines holding that scrutiny of startups not recognised by the Department for Promotion of Industry and Internal Trade on the angel tax issue will be conducted only after sanction from higher authorities so as to ensure the sources and also prevent undue harassment.


SMALLEST STENT INNOVATED Ref: The Times of India, Saturday, 10.08.2019



Scientists have recently created the world's smallest stent – 40 times smaller than any produced to date. Stents have been used to treat blocked coronary vessels for some time now, but the urinary tract in fetuses is much narrower in comparison, as stated by few researchers from federal Institute of Technology in Zurich (ETH Zurich), Switzerland. In order to prevent life

threatening levels of urine from accumulating in the bladder, pediatric surgeons have to surgically remove the affected section of the urethra and sew the open ends of the tube back together again.

Sun Pharma, India's largest drug maker, has entered into global licensing agreement with Hyderabad based CSIR Indian Institute of Chemical Technology for patents related to certain therapy areas with multiple indications. This move is certainly the part of earnest efforts to bring innovations from Indian research institutes to the market to address the unmet needs of patients globally. EU TO FOREGO MEDICAL DEVICES TRIALS Mint, Tuesday, 20.08.2019



The government has decided to do away with clinical trials for medical devices that have been approved and marketed for at least two years in European Union countries. This move is intended to speed up the availability of such medical devices in India. A notification to this effect shall be issued by the Union health ministry soon. The Medical Device Rules allow for an exemption in cases where the device does not have its predicate device (a legally marketed device that is not subject to premarket approval) in India before it

is sold or distributed by the regulatory authority in the US, the UK, Australia, Canada or Japan. The device should have been marketed in that country for at least two years, and the data of safety, performance and Pharma-co-vigilance of the device should comply with the standards of India's Central Licensing Authority. This proposal majorly seeks to remove regulatory bottlenecks while ensuring the availability and increased access to state-of-the-art devices in the Indian market.

Amazon Seller Services has moved the Supreme Court against direct selling Oriflame companies Amway, and Modicare, challenging a Delhi High Court judgment last month barring ecommerce platforms from selling products of direct companies without authorization. This judgement clarifies that neither ecommerce platforms nor sellers can sell any products without of Indian Direct Association. In order to check this trend, the Parliamentary standing Committee on Finance had recommended a regulatory framework for the direct selling business distinguish between legitimate companies and pyramid schemes.

It is a one-stop online central database or a deaf information network where provide information and resources are provided on how to meet the needs of the Indian deaf community. Tata Sia Airlines Limited who is the owner of the mark VISTARA under classes 12, 39, 21, 25, 27 and 28 using the mark since the year 2014 has filed a suit titled Tata Sia Airlines Ltd. vs. M/S Pilot18 Aviation Book Store & Another seeking permanent injunction restraining infringement of its registered trademarks, dilution, damages and rendition of

account against M/s Pilot 18 Aviation Book Store for selling and supplying VISTARA branded products on various e-commerce portals. The investigations which were subsequently conducted too revealed the Court vide order same. The dated 26th March 2019 restrained Defendants from manufacturing, selling, offering for sale, or dealing in any manner whatsoever with any VISTARA branded products, or any other mark or logo similar to VISTARA mark/logo. Along with this Court further went on to direct the Defendants to pay Rs. 2 lakhs to the Plaintiff in 1 month as costs and expressed concern regarding Defendant's behaviour of committing perjury presenting incorrect facts in written statement.

Unique GI tag has been recently awarded to renowned Palani Panchamirtham, the prasadam at Dhandayuthapani Swamy temple in Palani. The unique quality of this prasadam is that it is prepared by combining five natural substances like banana, cow ghee, cardamom, jaggery and honey for religious devotees at the top of Palani Hills by labourers and the employees of the temple. It is made under the guidance of Mysuru's Central Food **Technological** Research Institute, certified by Food Safety and Standards Authority of India (FSSAI) and without adding any water, preservatives or artificial ingredients in the absence of any

chemical processes. It is first ever GI tag awarded to a Prasadam.

Delhi High Court in an interim order has rejected the claim of NOVARTIS AG seeking injunction against Natco Pharma from manufacturing a cancer drug comprising the active pharmaceutical ingredient (API) "Certinib" for treatment of non-small cell lung cancer. The court held that there can be no claim for infringement with respect to a patent which has been revoked in a post grant proceeding. Balancing the interest of community at large vis-a -vis the right holder is indeed a tough and a tricky job but Delhi High Court has once again proved its mettle of balancing interests of all parties fairly well.
