
NOVEL IBC RULES Ref: The Economic Times, Wednesday, 03.01.2018

SPOTIFY VIOLATES COPYRIGHT Ref: The Times of India, Thursday, 04.01.2018








COFFEE GLIN INDIA Ref: The Times of India, Saturday, 06.01.2018



GULRAJ V/S NOVEX

Novex Communications has been issuing legal threats to all the big names in the hospitality and events business on the grounds that the latter are infringing the copyright in the music owned by Novex Communication. Novex Communications have been restrained from taking any coercive action against Gulraj Hotel which filed a threat action under Section 60 of the Copyright Act, 1957 by the Hon'ble Bombay High Court. The first issue dealt with in this case is whether Novex, can engage in the business of issuing licenses for its own music and second is a more fundamental question - is Novex actually the assignee of the performing rights for the entire catalogue of the music owned by Zee? This issue is now pending adjudication in both Mumbai High Court as well as Delhi High Courts.
