Delhi High Court has recently admitted Facebook's appeal against the court's order imposing a global injunction to take down defamatory content pertaining to yoga guru Baba Ramdev on its platform. A Division Bench of the Delhi High Court has clarified that while there would be no interim stay granted on the global injunction, Baba Ramdev cannot move a contempt application before disposal of the

appeal. This means that the social media giant will not face contempt proceedings for not following the global takedown order for the time being.

In the wake of rising privacy concerns globally, several cyber analysts and privacy experts have outlined the need for a surveillance reform and demanded a privacy law. Hacking of computer resources, including mobile phones and apps, is a criminal offence under the Information Technology Act, 2000 and this kind of law will put forth a model draft law that provides for judicial oversight and parliamentary controls in the surveillance process.

## IIT-D TO PARTNER ISRO Ref: The Times of India, Saturday, 02.11.2019





Homebuyers as well as regulators are troubled by builders' non-compliance with orders passed by Real Estate Regulatory Authorities (Rera). As a first of its kind, the Gurgaon bench of Harvana RERA has ordered attaching 10 acres in Gurgaon and four plots in Noida owned by Three C Shelters and putting it on sale for completion of four years delayed project. Suspecting that the builder could have used the concealed bank account to siphon off funds, the regulator has ordered similar audit of all other associated accounts and prohibited the builder from withdrawing any money from them. This is indeed a welcome step against the never-ending impasse that seems to be plaguing the Real Estate Sector.

## 3D BLOOD VESSELS PRINTING Ref: The Times of India, Tuesday, 05.11.2019



Indian-origin scientists' team has successfully developed a way to 3D print living skin complete with blood vessels. Researchers have noted that a significant barrier to integration of skin has been the absence of a functioning vascular system in the skin grafts. If key elements are added - including human endothelial cells, which line the inside of blood vessels, and human pericyte cells, which wrap around the endothelial cells – with animal collagen and other structural cells typically found in a skin graft, the cells start communicating. Such cells form a biologically relevant vascular structure within the span of just a few weeks.

#### ALGAE BASED DRUG APPROVED BY CHINA Ref: The Times of India, Tuesday,

China has recently approved a drug made by a Shanghai-based pharmaceutical firm, to treat Alzheimer's. In trials, the drug Oligomannate, statistically improved cognitive function in patients suffering from mild to moderate Alzheimer's as early as week four. This drug is unusual because it doesn't target beta amyloid, a protein that forms clumps of plaque in the brain and is thought to be a cause of the disease. This drug is world's first multi-targeting and carbohydrate-based drug for Alzheimer's.

#### APEX COURT OVERRULES APPROVALS Ref: The Economic Times, Wednesday 06.11.2019



The Supreme Court has set aside all environmental clearances given to a Tata Housing Development project near Chandigarh's Sukhna lake. In doing so, the court cited ecological disasters due to rapid urbanization. It was observed that the area in question fell within the catchment area of the lake and was only 123 meters away from the boundary of the Sukhna Wild life sanctuary.

IIT-Kharagpur had recommended introduction of mandatory Continuing Legal Education (CLE) for lawyers every year to be eligible to practice in any court.

Continuing Legal Education ensures that legal and judicial reforms contribute to changing the attitudes and behaviours of lawyers and citizens. For this reason, it has been proposed that CLE should be an integral part of legal and judicial reform strategies that are anchored on the rule of law and reflect a country's societal values. Though India has the second largest number of lawyers in the world, next only to the US, there is no mandate till date for them to undergo any further training once they have enrolled at the bar.

### RARE HIV STRAIN DISCOVERED <u>Ref: The Times of India, Saturday,</u> 09.11.2019



A US healthcare company has identified a subtype new of the human immunodeficiency virus (HIV) discovered first time in 19 years. The strain, HIV-1 Group M subtype L, has been recorded in three people in the Democratic Republic of Congo from blood samples taken between the 1980s and 2001. This sequence has now been made available to the research community to evaluate its impact on diagnostic testing, treatments and potential vaccines.

In this case, the petitioner who was teaching as a professor was accused of sexually harassing his own student. The court boldly declared that there can never be any iustification from the end of a teacher for committing abusive act towards his students. Infatuation on part of the student towards a teacher being recognized as a common phenomenon and pardonable but the teacher succumbing to the same and something reciprocating is unpardonable.
