India and US have signed a Memorandum of Understanding on Intellectual **Property** Cooperation. This Agreement between the Commerce Ministry's Department Promotion of Industry and Internal Trade and the United States Patent and Trademark Office aims to increase IP cooperation between both the countries. Both countries now have an opportunity to learn from each other's experience. This MOU shall facilitate the exchange and dissemination of best practices, experiences and knowledge on IP among the public as well as for all the stakeholders. There will also be a collaboration in training programs as well as exchange of experts. It will lead to fostering of best practices for registration and examination of applications for patents. trademarks, copyrights, geographical indications, and industrial designs, as well as the protection, enforcement and use of IP rights. Further, it shall also enhance the development implementation of automation modernization systems in IP and procedures for management of IP office services.

This dispute began when clothing company that was founded in the year 1962 approached Volkswagen-owned car firm in 1988 about branding clash. Several unsuccessful attempts were also made by BM to cancel clothing firm's Bentley trademark which it held since 1982 at the UK Intellectual Property Office.

# US OPENS PROBE INTO WHETHER VW VEHICLES INFRINGE JAGUAR LAND ROVER PATENTS

In the month of November 2020, Jaguar Land Rover registered a complaint with the US International Trade Commission seeking to prevent the import of VW Porche, Lamborghini and Audi models as they were allegedly infringing its patents. These models include LamborghiniUrus, Porche Cayenne and Audi's Q5, Q7, Q8, A6 Allroad and e-tron vehicles and VW Tiguan. The commission has now opened the matter for investigation but there has been no decision on merits yet. JLR has been constantly maintaining a stance that JLR's patented inventions are being used without any payment or permission. The patent mainly concerns the improved system for driving vehicle on different driving surfaces, in particular off-road. Its Terrain Response Technology maximizes performance on off road driving surfaces including grass, snow, mud, sand and rocks.
