LISBON AGREEMENT'S GENEVA ACT RECEIVES FIRST GEOGRAPHICAL INDICATION: KAMPOT PEPPER FROM CAMBODIA

Cambodia has recorded Kampot Pepper as the first Geographical Indication (GI), registered via the Geneva Act of WIPO's Lisbon System, which provides protection for names identifying the geographic origin of products such as coffee, tea, cheese, wine, pottery and cloth. Kampot Pepper is produced in the provinces of Kampot and Kep in Cambodia and since 2020 it is registered domestically as a geographical indication. This system that took effect in the year 2020 allows protection for appellations of origin and geographical indications in the 30 plus countries covered by the system through a single registration procedure and one set of fees, facilitating international trade of origin products. Appellations of Origin and Geographical Indications are distinctive product designations which require a qualitative link between the product to which they refer and its place of origin. Both are useful marketing tools for producers, as they inform consumers about a product's geographical origin, which influences the quality, characteristic and reputation of the product linked as being authentic. International Registration of Kampot Pepper under Lisbon System will further contribute to its success rate of export in international market. Local producers therefore will be able to enforce their rights in more than 30 countries including member states of European Union.

USING GOD'S NAME TO SELL ARTICLES ILLEGAL, RULES BOMBAY HIGH COURT

Bombay High Court declared that advertisement of any article using name of any God and claiming the same has supernatural qualities is illegal and falls under Maharashtra Prevention and Eradication of Human Sacrifice and other Inhuman, Evil and Aghori Practices and Black Magic Act. This order was passed in a petition filed by a teacher seeking injunction to prevent advertisements on TV Channels that promote sale of articles like Hanuman Chalisa Yantra. This Yantra was made of 24 carat gold and was priced at Rs. 4900 claiming to special and miraculous qualities, prepared by one Baba who was blessed by Lord Hanuman. The court while passing this order stressed on the role of education and spreading awareness in order to remove superstitions for a balanced society with healthy mind set for our children.

Science Technology and Innovation Policy has been proposed with an aim to establish a system whereby all researchers in India can access research published in top international journals for no cost. Vaibhav Taneja, Venkatrangam Sreeram and David Jon Feinstein have been named as Directors. According to ROC, it is registered as an unlisted private company with

an authorized capital of Rs 15 lakh and paid up capital of Rs.1 lakh. Tesla's entry has the potential to prove to be a catalyst for India's Electronic Vehicle industry that is still in its nascent stage. The EV charging infrastructure still remains underdeveloped in India. The supply chain for essential EV components, such as batteries, is also heavily dependent on imports, driving up the end-consumer costs of EV purchase and limiting the mass adoption of hybrid and electric vehicles in a price-sensitive market. The company is planning to set up an R&D center in India to tap into the strong pool of local engineering talent. Eventually, Tesla will also set up a manufacturing unit in India to bolster its indigenous production capabilities and market capabilities, as well as to strengthen its global supply chain. We can expect these developments to provide a major fillip to indigenous EV manufacturing by mobilizing direct competitors and potential ecosystem partners to provide more innovative offerings.

SAME GENDER SEXUAL HARASSMENT COMPLAINTS MAINTAINABLE UNDER POSH ACT: CALCUTTA HIGH COURT

of Internal Complaints Committee that refused to accept a complaint under the Act on the grounds that complainant and respondent belong to same gender and hence there is no jurisdiction. The Court categorically observed that Section 2(m) of the 2013 Act shows that the term "respondent" brings within its fold "a person", thereby including persons of all genders. The court held that the definition and concept of "Sexual Harassment" as enshrined under the Act needs to be interpreted against the backdrop of social perspective. A person of any gender may feel threatened or sexually harassed when his/her modesty or dignity as a member of the said gender is offended by any acts as contemplated in relevant sections irrespective of sexuality and gender of the perpetrator of the act. This landmark verdict points toward a trend of upholding the dignity of each life irrespective of gender and burying the fundamentals of prevailing age-old customs and traditions.
