The National Copyright Museum has been inaugurated in South Korea through a collaborative effort between the Ministry of Culture, Sports and Tourism and the Korea Copyright Commission. The museum's first floor provides an immersive journey into the creative process, offering insights into potential copyright challenges. The second level serves as an educational hub and provides a range of activities about the exhibitions located on the ground floor. A total of 415 historical and archival documents on copyright have been acquired by the National Copyright Museum. These resources include Yoo Gil-joon's "Seoyugyeonmun" (1895), the first Korean document to discuss copyright, and a 1961 photocopy of the Gutenberg Bible. This is indeed an innovative concept to create awareness among masses about relevance of copyright in daily life.

resulted into a finding that ST has sold infringing silicon carbide semiconductors. This patent covers groundbreaking technology involving silicon carbide semiconductors invented by Purdue University Professor along with his postdoctoral researcher. Purdue University is one of the top 4 patent-generating America. Purdue university in Research Foundation manages the Purdue Innovation Office Technology of Commercialization (OTC), which operates the technology transfer process. OTC vets invention disclosures from university personnel, applies for patents and other intellectual property protections, and licenses innovations to established companies worldwide. In the 2022 calendar year, PRF secured 192 patents from the U.S. Patent and Trademark Office. In fiscal year 2023, the office reported 150 deals finalized with 203 technologies signed, 400 disclosures received and 218 issued U.S. patents. This a welcome news for all inventors considering the scale at which the University is expanding in terms of research & development activities.

# GI TAG FOR MEGHALAYA'S LAKADONG TURMERIC

Meghalaya's Lakadong turmeric has been recently awarded the (GI) tag. Lakadong turmeric, which is found in Lakadong area of Jaintia Hills, has high curcumin content and the GI tag will help farmers in marketing as Lakadong turmeric is considered to be one of the world's best varieties of turmeric. It is darker in colour and is grown organically without the use of fertilisers. Few more products from Meghalaya have been awarded GI Tag recently namely-Dakmanda, which is a handwoven ankle-length lower garment, part of the traditional attire of Garo women of Meghalaya; Chubitchi, which is a rice-based fermented drink of the Garo community consumed during feasts and ceremonies and Larnai pottery, which is made of black clay from Larnai village.

#### ANCIENT PLANT SPECIES FOSSILISED BABY TURTLES Bafy nhm as uk. Manday, 11 12 2023

In the year 2003, two five-centimetre wide fossils covered in leaf-like markings were described as a new species of an ancient group of plants known as Sphenophyllum. This was quite surprising, as all known members of the group had died out more than 100 million years before the fossil was buried. To see if the fossils were really plants, a team of researchers reexamined them and discovered that the markings weren't the veins of leaves after all. but the ribs of tiny turtles. These fossils were nicknamed after Turtwig, which looks like a baby turtle with a leaf attached to its head. A closer look at the 'Turtwigs' revealed that they were very young at their time of death and were probably less than a year old. Within a few weeks of their death, the turtles would have ended up being buried and started their journey to becoming fossils. This revelation hopefully provides reassessment of plant fossils and inspire more researchers to delve into Colombia's fossil plant collections, and help to answer some of botany's larger questions.

Pochampally Ikat, which was India's first handloom product to get a GI tag, has been renewed for next ten years. GIs, like trademarks, are perpetual and only need to be renewed every ten years from the date of filing. The GI application was about to expire, and early action by the Registered Proprietor helped in the renewal of the GI for Pochampally Ikat. The GI logo of the Pochampally IKAT will also be submitted for renewal soon as it was filed separately.

OWNER OF TM OF A SHAPE CANNOT BE ALLOWED TO MONOPOLISE EVERY VARIANT Ref: verdictum.in, Monday, 18.12.2023



Delhi High Court in a case titled M/S Suman International & Anr. V. Mahendra Gulwani & Anr. has held that a party having registration in one shape cannot be allowed to monopolise each and every variant of the said shape only because both happened to be flowers. If that argument is accepted then the respondents would be entitled to seek injunction against every manufacturer who wants to manufacture a confectionary in a shape of a flower. In this case, Respondent claimed exclusive rights over a distinct rose-shaped lollipop and associated trademarks. The respondents contended that the appellants' product, 'SWEET ROSE LOLLIPOP,' bore a deceptive similarity, leading to confusion among consumers. The Court, in its October 2021 ruling, sided with the respondents. It cited resemblances in both the shape of the product and its packaging. Additionally, the Court took note of the recent launch of the contested lollipop by the appellants, which bolstered the respondents' argument regarding trademark infringement. The evidence laid before the court suggested that shape wasn't uniquely associated with the respondents' brand alone.

#### UNITAID AWARDS MILLION DOLLAR FUNDING TO ADDRESS IP RELATED BARRIERS Pafe unitaid and Tuesday, 19 12 2023

Working in partnership with the International Treatment Preparedness Coalition (ITPC), Third World Network (TWN), and Wemos, Unitaid will contribute to equitable access to health products of public health importance by improving affordability, building capacity and improving supply of key tools for HIV, TB, hepatitis C, cervical cancer, and public health emergencies, in complementarity with other access strategies such as voluntary licenses. Before the COVID-19 pandemic many people lacked access to essential medicines. Then the pandemic overloaded health systems and set back progress on diseases such as HIV, tuberculosis (TB), malaria, and hepatitis C, among others. It also laid bare profound disparities in the way that health research is conducted and how access to innovation is determined. This kind of intervention is much needed in post pandemic era as without timely intervention, inequitable access will only widen, and populations that are already vulnerable and marginalized will face increasing risk of disease, poverty, reduced quality of life and even death. These new collaborations will ensure the products are affordable and available to everyone in Lowand Middle-Income Countries who needs them.

BUZZFEED, SEMAFOR SUED OVER TRADE SECRET THEFT Ref: businesstoday.in, Friday, 22.12.2023



Ozy Media has sued digital media company Buzzfeed, a startup news outlet Semafor and its founder Ben Smith for allegedly stealing trade secrets from the now-shuttered US media and entertainment company. Smith had launched Semafor in October 2022. As per the complaint, Smith gained an inside view into the company's operations when Buzzfeed, the digital media outlet he once led, considered acquiring Ozy in 2019. The lawsuit seeks unspecified compensatory and punitive damages, as well as to have Smith and Semafor pay Ozy all gains, profits and advantages derived from the alleged theft. Ozy had shut down in October 2021 after Smith, then a New York Times media columnist, reported that Ozy co-founder Samir Rao impersonated a YouTube executive during a fundraising call with Goldman Sachs and said many of the media company's videos attracted more than a million views on the platform.

This is a first of its kind facility in the country that is focussing on incubation for GI tagged communities engaged in market linkage activities. Under this incubation arrangement, VKF will be providing support for this initiative by handholding the GI farmers, Self Help Groups and other stakeholders for improving product quality. enhancing the the marketability, providing better market linkages for the GI tagged products. VKF is planning to set up Common Facility Centers (CFC) under the Micro Small and Medium Enterprises (MSME) Cluster Development Programme (CDP) scheme to provide much needed value addition to these GI tagged products.
