The Foundation has three trademarks registered under the name and style-"Windrush Heritage, Windrush Pioneers and Windrush Foundation. Six more trademarks were filed in the year 2021 and 2022 under the style-Windrush, Windrush Monument, Windrush Memorial, Windrush Windrush70 and Windrush75. Subsequently oppositions were filed against

these marks for applications being made in bad faith and without any intention to use the marks with respect of the services claimed. The oppositions were upheld and the Foundation has been ordered to pay £3,800 to the government as costs after losing the trademark dispute.

BIS, AGMARK CERTIFICATION NO LONGER A REQUIREMENT

FSSAI has recently decided to do away with need for Bureau of India Standards (BIS) or AGMARK certification for food products that have FSSAI license with them. This move will definitely go a long way in fostering ease of doing business in the food industry in the country as now separate certifications for quality standards will no longer be required. comprises representatives **FSSAI** different ministries that include Commerce, Consumer Affairs, Law, Micro, Small and Medium Enterprises, State and Industry Players. FSSAI has also decided to bring about standards for "Haleem" as part of standards for meat products. Haleem is a dish made of meat. pulses, grains, and other ingredients, which currently does not have any set standards. Other approvals by the FSSAI include standards of Mead (Honey wine) Alcoholic Ready-to-Drink (RTD) beverages, revision of standards of milk fat products.

RBI PROPOSES NEW AUTHENTICATION METHODS FOR DIGITAL PAYMENTS

RBI has recently announced a new way to verify digital payments. Instead of just using SMS-based OTP's they are introducing a principle based authentication framework. The reason behind this new change is the shift in the digital payment landscape within the country along with better security. When one initiates an online transaction, one receives an OTP which must be entered within a specified time frame in order to authenticate the transaction. According to new rules, RBI regulated entities will have flexibility to utilise alternative authentication methods which includes Time-based One Time Passwords generated through algorithms or other authentication techniques.

DJIBOUTI JOINS GENEVA ACT OF WIPO'S LISBON AGREEMENT

In the month of February, Government of Djibouti has deposited its instrument of accession to the Geneva Act of the Lisbon Agreement on Appellations of Origin and Geographical Indication. With this accession, the Geneva Act now offers protection in 22 Contracting Parties covering up 58 countries, while the Lisbon System covers up to 73 countries in total. The Geneva Act helps producers of quality products, linked to origin, to protect the distinctive designations of their products in multiple jurisdictions, either as appellations of origin or geographical indications, through a single application filed with WIPO, and the payment of one set of fees. The Lisbon System provides protection for names that identify the geographic origin of products such as coffee, tea, fruits, cheese, wine, pottery, glass and cloth. This accession will enable producers and other interested stakeholders of Djibouti to quickly and easily secure international protection of distinctive designations of their origin products - such as the Sel du Lac Assal (Salt from Lake Assal), but also the renowned

DRDO INKS TECHNOLOGY TRANSFER IN ELECTRONICS, LASER TECH, COMBAT VEHICLES, NAVAL SYSTEMS & AERONAUTICS

The Defence Research and Development Organisation has handed over 23 Licensing Agreements for Transfer of Technology to about 22 industries in the domains including but not limited to electronics, laser technology, vehicles, naval systems combat aeronautics. The agreements are usually for manufacture of Carbon/Carbon Aircraft brakes for Light Combat Aircraft Tejas, the 100 m Infantry Foot Bridge Floating, 40 mm high Explosive Anti-Personnel Grenade for UBGL and the Full Trailer of a 70t Tank Transporter for the MBT Arjun Mk- 1A. SAMAR (System for Advance Manufacturing Assessment and Rating) assessment certificates have also been handed over to 9 industry partners. All these efforts will make the country self reliant in technologies defence and provide opportunities to industries in defence manufacturing sector.

CABINET APPROVES RS 75,000 CRORE ROOFTOP SOLAR SCHEME

Union Cabinet has recently approved a scheme to install rooftop solar power in homes. The scheme provides a CFA of 60 % of system cost for 2 to 3kw capacity and 40 % of additional system cost for systems between 2 to 3 kw capacity. The CFA will be capped at 3kw. Households can apply for subsidy at a national portal where they can select a vendor for installing rooftop solar. The portal will assist households in their decision by providing information such as system sizes, benefits calculator and vendor rating. The Cabinet also approved setting up model villages in all districts of the country for the adoption of rooftop solar. The scheme will serve people who consume less than 300 units of electricity, typically lower and lowermiddle-class households in urban areas.

RESEARCHERS DISCOVER A NEW PLANT SPECIES

A new species has been discovered in Japan which is tiny glass-like white plant that feeds on fungi. Fairy lanterns or Thismiaceae are very unusual plants found in tropical, subtropical and temperate regions. Since they are not green, they do not engage in photosynthesis and feed on fungal mycelia in

the ground. They are often hidden under fallen leaves and produce above-ground flowers that look like glasswork for a brief period. The Japanese name for Thismia is "Tanuki-no-shokudai" which means "raccoon dog candleholder" and refers both to their shape and underground lifestyle. The last discovery of a new vascular plant concurrently identified as a separate genus was the discovery of Japonolirion in 1930, almost 100 years ago.
