WIPO GUIDE ON TRADESECRETS

Recently, importers and exporters are aggrieved by the misuse as well as leaking of confidential data submitted by them to the Customs through ICE-Gate portal. WIPO Guide on the protection of trade secrets is available for access and guidance which has separate section dealing with strategic roles of Trade secrets in the innovation ecosystem. Trade secrets are confidential information, not generally known among, or accessible to, the persons in the relevant business sector but are of commercial value. Thus, the holder has a responsibility of ensuring that reasonable steps are taken for its protection. As we do not have a statute for its protection, thus common law can be enforced through courts as applicable. The WIPO guide is an elaborative compilation and should be used as a ready reckoner compendium for all interested parties.

MISLEADING ADVERTISEMENTS CENTRALISED DASHBOARD
